Green Certificates – When do you come? Not prior to Q2/2011?

According to law 220/2008 for the establishment of the system to promote energy production from renewable resources as amended by law 139/2010 the allocation of Green Certificates ("GC") was modified as follows:

- Electricity from hydropower plants with installed power of not more than 10 MW:
 - o 3 GC per 1 MWh (new power plants);
 - o 2 GC per 1 MWh (refurbished power plants);
 - o 1 GC for each 2 MWh (old power plants);
- Electricity from the **wind energy** plants:
 - o 2 GC per 1 MWh (until 2017) and
 - 1 GC per 1 MWh (starting with 2018);
- For the **solar plants**: 6 GC per 1MWh;
- For all the **other** above mentioned **renewable energy sources** 3 GC per 1MWh.

The prices of the GC remain the same, within the limits of 27 to 55 Euro/GC.

Within 3 month from the day Law 139/2010 will enter into force, ANRE has to issue the Methodological Norms on implementing Law 220/2008. This term expired on October 9, 2010 without the release of any act.

We have been informed that on 17.11.2010 the European Commission sent a questionnaire to the Romanian government.

Therefore, insiders expect that the approval of the European Commission will not arrive earlier than Q1/2011. Furthermore, it is expected that the Methodological Norms will not be issued by ANRE prior to Q2/2011.
